1. Recommendation

It is recommended that Council receive this report for information.

2. Purpose

This report is a statement, required by legislation, of the remuneration and expenses paid in 2016 to:

- Each member of Regional Council, in respect of his or her services as a member of Regional Council or local board, and
- Each person, other than a member of Regional Council, appointed by the Region to serve as a member of a local board.

2016 Statement of Remuneration and Expenses for Members of Council and Local Board Appointees

3. Background

An annual statement of remuneration and expenses is required by the Municipal Act

Section 284(1) of the Municipal Act requires the Regional Treasurer to provide a statement of remuneration and expenses to Council, on or before March 31 of each year, of amounts paid to members of Regional Council and appointees to local boards in the previous year.

4. Analysis and Options

Remuneration and expenses for Members of Regional Council were paid from the operating budget

Regional Councillor remuneration is established under the authority of Bylaw No. A-215-96-132 and Bylaw No. A-215(a)-2000-001.

Attachment 1 summarizes the 2016 amounts paid to Council members in respect of his or her services as a Member of Council. Funds were approved in the 2016 Regional Budget adopted on December 17, 2015.

Local municipalities pay the Members of Regional Council and are reimbursed by the Region

Under the terms of an agreement, salary and benefits are paid by the local municipalities to their respective members of Regional Council and recovered from the Region.

Annual Councillor remuneration for 2016 was \$54,337 from January 1 to March 31, and \$55,234 from April 1 onwards. The differences in remuneration among councillors are due to variations in pay periods and benefits coverage among municipalities. Benefits include the Region's share of contributions or premiums for OMERS, Canada Pension Plan, life insurance, extended health, dental and long term disability coverages. Benefit coverages vary among the local municipalities.

Payments from three Local Boards and Authorities to Regional Councillors and Appointees are reported

In 2016, four Regional Councillors and one local municipal councillor were appointed to the Toronto and Region Conservation Authority. Similarly, five

Regional Councillors and three local municipal councillors were appointed to the Lake Simcoe Region Conservation Authority.

Payments for their services to the Authorities are detailed in Attachments 2 and 3. The four local municipal councillors appointed to the conservation authorities are listed in Attachment 4.

Expense reimbursements to Regional Councillors on the York Regional Police Services Board are reported in Attachment 5.

5. Financial Implications

Funding for remuneration and expenses for Members of Council is included in the annual operating budget.

6. Local Municipal Impact

The single payer arrangement between the Region and the local municipalities does not result in any increased costs to the local municipalities. Local municipalities invoice the Region for the Region's portion of salary and benefits based on payments to their respective Regional Councillors.

7. Conclusion

This report was produced to provide a statement, required by legislation, of the remuneration and expenses paid in 2016 to each Member of Council in respect of his or her services as a Member of Council, and to a Member of Council or other person who has been appointed by the Council to serve as a member of a local board or authority.

Dear Mr. Hughes:

Section 247 (1) of the Municipal Act, R.S.O. (1990) requires municipal treasurers, to submit to Council a statement of remunerations and expenses paid in the proceeding year to each member of Council with respect to his/her services as an official of the municipality, membership on a local board or other body.

The individuals who were appointed to Toronto and Region Conservation Authority (TRCA) by the Council of the Region of York received the remuneration and expenses for 2016 outlined in Attachment 1. Per diem paid was \$86.62 per meeting per twenty-four hour period and the mileage rate was fifty cents per kilometre (\$0.50/km). Per diem was ½ the regular per diem rate (\$43.31) if participated in meetings by teleconference.

The Chair, as an elected municipal member, receives two-times per diem, as does the Vice Chair when acting in the place of the Chair (\$173.24). The Chair and Vice Chair were a City of Toronto appointee and a Region of York appointee, respectively. The noted remuneration rates were approved by the Ontario Municipal Board in June, 2008.

Members are given the opportunity to collect, waive or donate remuneration and/or expenses. If a donation is requested, this is done internally by TRCA staff as a direct transfer from TRCA to The Living City Foundation.
