AED Registration Information

The AED Registry is an optional repository of publicly and privately available AEDs (Automated External Defibrillators). The registry is maintained by York Region Paramedic Services and accessed by our 911 dispatchers when someone calls 911 for a cardiac-related emergency. The 911 call taker will access the registry to identify the nearest AED during an emergency and provide necessary instructions.

Frequently Asked Questions

Why should I register my AED?

During a sudden cardiac arrest, every second counts. For every 1 minute delay in defibrillation, survival rate decreases by 10 per cent. Having your AED registered increases public access to these life-saving devices and can help save lives in your community and workplace.

What are the benefits of registering my AED?

- a. When a registered AED is used during a cardiac emergency, York Region Paramedic Services will assist you and your organization through the next steps. This includes providing you with free replacement pads and other common AED accessories used while acting to save a life. We also follow up with those involved in the incident and answer any questions they may have about their experience and involvement.
- b. If your organization is hosting a large event or off-site gathering, registered AED owners can borrow an AED for these events free of charge.
- c. If your AED cannot be serviced on-site after being used, we will provide a loaner until your registered AED is rescue ready.
- d. You can sign up for email notifications to inspect your AED and expiration date reminders.
- e. You will receive an information tag to attach to your AED that provides information on “Next Steps” after the AED has been used.
- f. Your AED will be made visible to 911 dispatchers.

How much does registering cost?

There is no cost associated with registering your AED.

What are my responsibilities?

You are required to complete maintenance checks as per the AED manufacturer, and ensure that your AED device is rescue ready at all times. This includes replacing expired equipment associated with your AED.

You have the option to automatically receive notifications via email or maintenance and replacement of expired pads. York Region Paramedic Services only replaces pads after an AED has been used for a sudden cardiac arrest.

How do I update my registration information?

Changes can be made by submitting a new registration form with the most current information.
