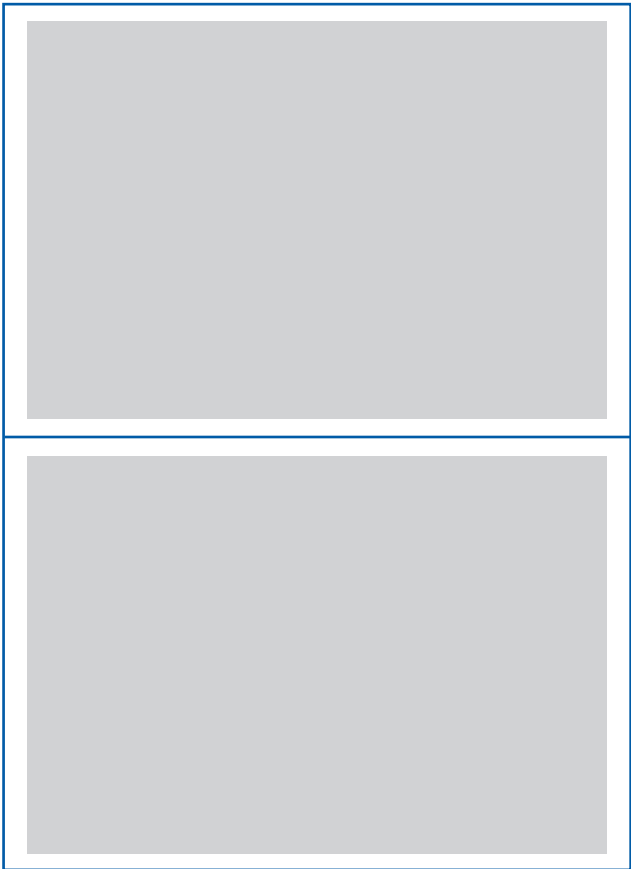

Section 207 of the *Highway Traffic Act* and subsection 5(2) of Ontario Regulation 355/22 provide that you, as the owner of the motor vehicle, are liable for this penalty even if you were not the driver at the time, subject to limited exceptions. 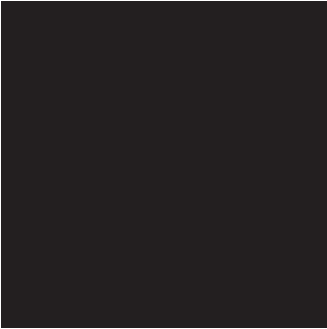

Option 2 – Dispute

Dispute/Request an Appeal

The owner of the motor vehicle may request an appeal of this Penalty Order **no later than 30 days** after the deemed service date. Screening Officers may confirm, set aside or vary the Penalty Order, including granting additional time to pay or providing a payment plan.

An additional fee of \$60, pursuant to Ontario Regulation 355/22, will be added to the total amount owing for failing to attend any stage of an appeal. For more detail regarding disputes or appeals, please visit york.ca/PayMyPenalty

Applicable Manner of Appeal

Notice: Failure to Pay the Administrative Penalty Order
Failure to pay the amount owing **within 30 days after the deemed service date** may result in additional fees, including a late payment fee of \$20, being added to the amount owing and this matter being referred to the Ministry of Transportation for plate denial. This may result in your Ontario licence plate not being in good standing and it may not be automatically renewed until the penalty and all associated fees are paid in full. Any unpaid administrative penalty amount or any insufficient funds fees shall constitute a debt to The Regional Municipality of York or Province of Ontario, as applicable.
