BYLAW NO. 2016-21

A bylaw to amend Bylaw 2015-67 being a Bylaw to remove a part of Woodbine Avenue (YR 8) from the Regional Road System in the City of Markham

WHEREAS Regional Council enacted and passed Bylaw 2015-67 on November 19, 2015 wherein a portion of the original Woodbine Avenue (YR 8) was removed from the Regional Road System as shown as a bold black line on Schedules "B" and "C" to the said Bylaw; and

WHEREAS reference plans have been deposited at the York Region Land Registry Office, and a more accurate description of the lands contained in Schedules "A", "B" and "C" of Bylaw 2015-67 is now available to clarify the boundaries of respective jurisdictions between The Regional Municipality of York and The Corporation of the City of Markham.

The Council of The Regional Municipality of York hereby enacts as follows:

1. Bylaw 2015-67 is hereby amended by replacing Schedules "A", "B" and "C" thereto with Schedule "A" attached.
2. Schedule "A" attached shall form part of this bylaw.
