

THE REGIONAL MUNICIPALITY OF YORK

BYLAW NO. 2016-13

A bylaw to add certain lands to the Regional Road System
in the Town of Richmond Hill

WHEREAS certain lands were established as public highway under the jurisdiction of the Corporation of the Town of Richmond Hill,

AND WHEREAS the said lands form parts of various intersections along Yonge Street (YR1) and it is appropriate that the said lands be assumed by The Regional Municipality of York to form part of Yonge Street (YR1);

AND WHEREAS certain lands were established as public highway under the jurisdiction of The Regional Municipality of York, as more particularly described in Schedule "C" but were omitted from the consolidation of the Regional Roads Bylaw and it is appropriate that the said lands be formally assumed;

NOW THEREFORE, the Council of The Regional Municipality of York hereby enacts as follows:

1. The lands described in Schedules "A" and "B" are hereby assumed by The Regional Municipality of York and shall form part of Yonge Street (YR1).
2. The lands described in Schedule "C" are hereby assumed by The Regional Municipality of York and shall form part of 16th Avenue (YR73).
3. Schedules "A", "B" and "C" attached shall form part of this bylaw.
4. Bylaw No. 2015-52 is hereby repealed.

SCHEDULE "A"

Lands in the Town of Richmond Hill in the Regional Municipality of York being composed of:

FIRSTLY: Part of Observatory Lane, Registered Plan 4342, being Part 3, Plan 65R35195, Town of Richmond Hill.

SECONDLY: Part of Baif Boulevard, Registered Plan M1435, being Parts 1, 4 and 5, Plan 65R35194, Town of Richmond Hill.

THIRDLY: Part of Lots 42 & 43, Concession 1 (Geographic Township of Vaughan), Town of Richmond Hill more particularly described as Part 1 on Plan 65R-36001.

FOURTHLY Part of Lots 42 & 43, Concession 1 (Geographic Township of Markham), known as Weldrick Road East, Town of Richmond Hill more particularly described as Part 2 on Plan 65R-36001.

FIFTHLY: Part of unnamed street, registered Plan 2260 (Geographic Township of Markham) being Clarissa Drive, Town of Richmond Hill more particularly described as Parts 5 and 8 on Plan 65R-36001.

SCHEDULE "B"

Lands in the Town of Richmond Hill in the Regional Municipality of York being composed of:

FIRSTLY: Part of Lot 24, Registered Plan 1642, known as Brookside Drive, being Part 2, Plan 65R35453, Town of Richmond Hill.

SECONDLY: Part of Naughton Drive, Registered Plan 3600 (geographic Township of Vaughan), being Part 1, Plan 65R35443, Town of Richmond Hill.

THIRDLY: Part of Bernard Avenue, Registered Plan 65M-2819, being Part 1, Plan 65R35458, Town of Richmond Hill.

FOURTHLY: Part of Leonard Street, Registered Plan 293 (geographic Township of Vaughan), being Part 1, Plan 65R35444, Town of Richmond Hill.

SCHEDULE "C"

Lands in the Town of Richmond Hill in the Regional Municipality of York being composed of Parcel 41-17, Section MA-1, being Part of Lot 41, Concession 1, East of Yonge Street, in the Town of Richmond Hill, in the Regional Municipality of York (geographically in the Township of Markham, County of York) designated as Parts 5, 7, 8, 13 and 14 on Plan 65R-15480.
