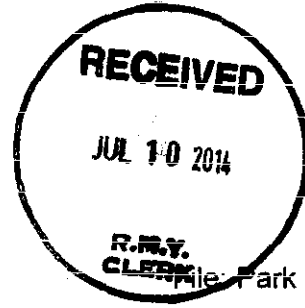

**Re: Speed Reduction Request – Park Road**

At its meeting of June 18, 2014, the Council of the Town of Georgina passed the following Resolution:

**RESOLUTION NO. C-2014-0373**

That the request by Andrew Aitchison to reduce the speed limit on Park Road from 60 km/h to 50 km/h, to paint solid lines on the roadway to prohibit passing and to install 'Slow, Watch for Children' signs be received and referred to staff to forward these requests to the Region of York as Park Road is a regional road, and to request York Regional Police to install a temporary electronic speed indicator sign on Park Road to determine the average speed of vehicles in this area.

As such, the Town is seeking the Region to reduce the speed limit on Park Road from 60 km/h to 50 km/h in the area between Black River Road and Hedge Road.

The Town is also requesting that solid lines be painted on this section of roadway to prohibit cars passing and to install the appropriate Slow, Watch for Children signs.

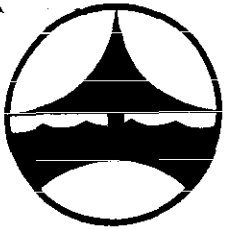
